## **Our Foundation:**

My grandmother (Elsie) always made the most delicious apple pies. One year during the holiday season we asked her to write down her recipes. She couldn't do it! She said she didn't learn from a recipe—her mother (my great-grandmother) taught her by making pies with her. She said you need to see and feel the ingredients come together. The tradition was carried down from my dad (Papa C) to me. When you make something often enough and you love to make it, you don't need a piece of paper to tell you how.

## **Papa C Pies Beginning:**

Papa C Pies was incorporated on 4/1/2009 (yes, April Fools Day)! in the shadow of the 2008 recession. Initially we drove 50 miles to Woodbury to use a UT Ag Extension Kitchen for a year and a half. And then we drove 50 miles to Clarksville to use a large Ag Ext kitchen. Those were early mornings, long days, and long hours. We would sell at farmers markets, fairs, and festivals.

We opened our retail storefront kitchen in 2016 in Cool Springs (located behind Costco). We sell to the public, ship pies across the country, and we also wholesale to retail and restaurants. We believe in quality and honoring my Grandmothers recipes and the ones my dad and I created together through quality ingredients, taking the time to ensure a great product and with excellent customer service.

## **Commitment to Quality:**

Pie is interesting in that the filling and the crust both must be great! If you love pie We know those times when the filling was good, but the crust tasted like cardboard and ruined the experience. Despite the saying, it is not as easy as pie! There is a lot of labor and effort, but a great pie does 2 things: It gets you talking about a memory you had eating pie and it creates a memorable experience at that moment with those you are with. I have a saying: People share cake, but they fight over pie!

We use fresh quality ingredients and we make them by hand in our store! The only equipment we have is a Hobart 40 Quart mixer. So our items cost a bit more, but we feel like that is reflected in the quality and the taste. People want to buy products that remind them of grandma and when it comes to pies you want ***a crust you can trust!***

Papa C Pies believes in utilizing non-GMO Unbleached flour and Whole wheat flour in our crusts as well as Sugar in the Raw Turbinado sugars. The company is licensed, permitted, and inspected through the Department of Agriculture and is a member of the Better Business Bureau (BBB) with an A rating, is an active member in the Williamson County Chamber of Commerce, The Heritage Foundation, and Pick TN Products. Chad is a Middle Tennessee native and earned his bachelors degree from Belmont University.
